### Overview

The North Central District Health Department (NCDHD) provides our eight (8) Member-Towns with full time public health services. We are on call 24/7 for emergencies. The Health District is governed by a Board. Enfield is represented by Jason Walsh, Michael DellaVolpe, James Hoyne, Brandon Jewell and Dean Gousse.

The Health District is comprised of Environmental Health, Community Health, Public Health Emergency Preparedness, & Administration Sections.

# NCDHD Activities

## Highlights

The Health District received a \$300,000 grant in November to address opioid misuse and overdoses. This competitive funding opportunity was offered by the National Association of County and City Health Officials (NACCHO). NCDHD received 1 of 20 awards in the country. The Health District invited Hartford Healthcare, the Town of Manchester, Eastern Highlands Health District, and CT Greater Harm Reduction Alliance to partner with us on this project.

Project activities include sharing overdose data with first responders in our jurisdiction, a media campaign including an increased social media presence, and providing Narcan trainings and referrals for treatment. For more information, follow us on Instagram @northcentraldistricthd.

## Food Protection

In February of 2023, The CT Department of Public Health transitioned to the FDA Food Code. This transition has resulted in many changes for licensed food establishments and staff, as we work to navigate this new code and process. The Health District is responsible for plan review of all proposed food service establishments or renovations to existing ones, and changes of ownership of existing food establishments. In addition to inspection of restaurants, NCDHD inspects the broad range of food establishments that serve the public. Temporary food events, which include fairs, carnivals, car shows, and other public events where food or beverage are served have increased significantly since the pandemic.

## Septic Systems

NCDHD is responsible for the issuance of permits for on-site sewage disposal facilities. Soil investigation, the location and method of installation are governed by the Public Health Code and are enforced by NCDHD. This process requires preliminary site reviews, comprehensive soil testing, review of plans, installation inspections and a final issuance of a Permit to Discharge.

## Public Pools

Each Summer season, NCDHD collects water from public swimming areas in our district to test for bacteria. If the levels are elevated, the location is closed to swimming until the bacteria level is no longer elevated. 10 sites are tested within our jurisdiction.



## Lead

Lead poisoning is one of the most preventable serious diseases in children. Even relatively low levels of lead in blood may lead to permanent damage to the nervous system and brain, interfere with growth, make learning difficult and affect I.Q. scores. NCDHD addresses cases of childhood lead poisoning within the District's Member-Towns. The State of Connecticut has reduced the level that will constitute a "lead poisoned child". This will significantly increase the number of lead cases in the next few years. Children with elevated blood lead levels is often associated with older housing stock.

NCDHD reviews and approves plans for cosmetology salons, barber shops and licenses and inspects these establishments.

Re-inspections are conducted as necessary.





## Communicable Diseases/Nursing

Our Public Health Nurse tracks all reportable diseases. Although COVID is no longer a public health emergency, clusters of illness are followed up on. Information on COVID vaccine and preventing illness at home, in the workplace, and in the community are provided at outreach events. The Health District also provides flu vaccine in the fall and can bill several insurance companies. The Public Health Nursing staff just completed a grant project that involved working closely with long-term care facilities in our jurisdiction. The work will continue beyond the grant period with quarterly meetings and a toolkit that will assist long-term care facilities in their efforts to prevent and reduce communicable illness.



## Public Health Preparedness

NCDHD participates in Preparedness Region 3 and Region 4 planning and exercising activities. One of these activities is quarterly call-down drills which help to assure a fast response in the event of an emergency. Our Preparedness Coordinator is also actively tracking weather that is likely to result in significant flooding and/or power outages.



NCDHD Director of Health, Patrice Sulik, and some of our team members had the pleasure of attending Enfield's Community Conversations: Working Together To Impact The Opioid Epidemic. Our Director, along with the Chief of EMS, the Chief of Police, Drug Intelligence Office New England High Density Drug Trafficking Area, and the Public Health Analyst CDC Foundation spoke about the impact of the opioid epidemic on the community and their efforts in combatting it. The Town of Enfield and Enfield Social Services were also key in hosting this event!
