REQUEST FOR PROPOSAL FOR PROFESSIONAL AUDITING SERVICES

The primary purpose of the audit is to express an opinion on the general purpose financial statements taken as a whole, in the form of an auditor's report. This audit is to be performed in accordance with generally accepted auditing standards, the standards set for the financial audits in the General Accounting Office's (GAO) Government Auditing Standards (1994), the provisions of the Federal Single Audit Act of 1984, as amended in 1996, and U.S. Office of Management and Budget (OMB) Circular A-133, Audits of States, Local Governments and Non-profit Organizations, and the provisions of Sections 4-230 through 4-236 of the Connecticut General Statutes concerning the State Single Audit Act.

The deliverable is an independent auditor's report and any other reports required of the independent auditor examining the financial statements of the NCDHD in accordance with the standards listed above. The report shall state the scope of the examination and consist of examinations of all necessary NCDHD financial statements. The report must also state that the audit was performed in accordance with generally accepted auditing standards. Additionally, the NCDHD expects the successful applicant to provide advisory guidance regarding accounting and technical matters, as needed, to keep the NCDHD in compliance with accounting and reporting standards. A final deliverable is an exit meeting with the NCDHD Director and key Board Members.

Applicants are required to submit three (3) hard copies of RFP responses by Friday, April 29, 2016 by 4:30 PM at the NCDHD's office in Enfield. All submissions should be sealed and labeled with the title of this RFP. Bids will be opened promptly at 4:30 PM on April 29, 2016 at the Enfield Office of the North Central Health District, 31 North Main Street, Enfield, Connecticut. Emailed bids will not be accepted. Any questions should be directed to Patrice Sulik, Director of NCDHD via the email listed on the first page of this RFP by April 21, 2016 at 4:30PM. All questions asked and all answers given will be posted on the ncdhd.org website by April 25, 2016.

The NCDHD will assess applications based on experience in conducting audits with government entities or non-profits in Connecticut (particularly local health districts), knowledge of accounting principles and value.

The NCDHD reserves the right to request additional information or clarifications from proposers, or to allow corrections of errors or omissions. There is no expressed or implied obligation for the NCDHD to reimburse firms for any expenses incurred in preparing proposals in response to this request.

- The NCDHD mission is to prevent disease, injury, and disability by promoting and protecting the health and well-being of the public and our environment.

District offices are located in Enfield, Stafford, Vernon, and Willimantic.
